#### Chair Report

Our July ACM was attended by about 49 people – 29 in person and 20 online. I am continually grateful for our tech committee that provides a hybrid option to enable online participation.

- Our area has been discussing the possibility of making changes to our assembly structure, and we have formed an ad hoc committee to consider feedback from our area and propose alternative options and a recommendation to consider for our 2027 assemblies. We will consider and discuss options at our August Area Committee Meeting (ACM) and revise as needed to present a final proposed recommendation for consideration at our September ACM. Any proposed changes to our assembly structure will be brought to an area assembly for consideration by the body.
- I had the opportunity to present a *Lean into Service* workshop in District 42 (Fresno) last month. Thank you, Bill L. (DCM, D42) for the opportunity to present, Christina A. (DCM, D21) for the help in planning the workshop(s), and to Carrie J. (DCM, D40/Webmaster) and Michael P. (GSR/Tech Committee) for an outstanding job sharing their general service experience!
  - There will be two more *Lean into Service* workshops in the coming weeks, and I invite you to join us for either of these hybrid events hosted by Districts 11 and 37. *The purpose of these workshops is highlight various opportunities and paths to service in our area, motivate others to get involved with general service, and to cultivate future service leaders in our area. - Our Fall Assembly will be hosted by District 37 in Tracy on November 14-16. This is a 3-day assembly that starts on Friday evening and goes thru Sunday afternoon. 



#### **New Business:**

- \* Process to loan Area's translation equipment.
